Emails & Documents

 When sending emails and documents to DOA, please be patient while awaiting a response. Your email and/or document is not the only one that must be attended to. Each section in State Payroll Operations is responsible for over 200 agencies

SharePoint

- Documents should be uploaded to SharePoint instead of emailed, unless otherwise specified
- If you don't have access, submit an SPO SharePoint Security request (found on the SPO Forms webpage) to payroll@doa.virginia.gov
- Please be careful when creating folders. We only receive notifications for folders that have been created by DOA. Your document may not be seen if placed in a folder not created by DOA
- Make sure you are uploading documents to the correct folder. We only get notifications for the folders we are assigned to
- Do not upload documents to the SPO to Agency Folder. This folder is for documents DOA sends to your agency

Write-Ups

- Beginning with the 1st quarter in 2024 agencies will be written up and reported in the Comptrollers Report for the following:
 - Not submitting certs
 - Late submissions
 - Not making corrections when asked
 - Incomplete certifications



WHAT IS THE QUARTERLY CERTIFICATION?

- The Quarterly Certification is an excel workbook that all agencies must submit at the end of each quarter to ensure employees' tax records are correct for W2 processing at the end of the year. The workbook contains a total of 6 tabs (Reports Reconciliation, Quarterly Tax Cert, Differences Explanation, Fed to State Recon, OASDI Recon, & HI Recon).
 - The tax information on the W2 comes from the employee's tax balances on the Balance Review screen in Cardinal
 - For quarters 1-3 the quarterly certification is usually due on the first Friday after the quarter ends. For 4th quarter pay attention to the payroll bulletins and emails for a due date







- Make sure you key the number of balance adjustments you are sending to DOA

VALID VS. INVALID DIFFERENCES

Valid Differences

- Employees in states with no state taxes, Pennsylvania, New Jersey
- Employees who have uncollected FICA due to imputed life
- Differences will clear once keyed on the corresponding tab
- No correction is necessary

Invalid Differences

- Employees set up incorrectly
- Incorrect balance adjustment keyed
- Balance adjustment keyed for following quarter (no correction necessary)
- Employees who have uncollected FICA for any reason except imputed life
- Differences will remain on the Ortrly Tax Cert tab
- Differences must be explained on the Differences Explanation tab
- Differences must be corrected through payroll or by submitting a balance adjustment form

WHAT DO I DO IF THE QUARTERLY TAX CERT TAB HAS DIFFERENCES???



SOME POSSIBLE CAUSES

- You keyed incorrect amounts on the Reports Reconciliation tab
- Employee's Tax Data is/was set up incorrectly in Cardinal
- FIT/SIT balance adjustment was keyed in the following quarter
- Valid state tax differences (Out of State taxes) have not been keyed on the Federal to State Recon tab
- Uncollected FICA for any reason <u>EXCEPT</u> Imputed Life
- FICA tax or FIT/SIT taxable amounts keyed on balance adjustment form were incorrect or keyed incorrectly

FEDERAL & STATE TAXABLE DIFFERENCES

Valid Differences

- Employees who are set up in a state that does not have state taxes
 - Alaska, Florida, Nevada, New Hampshire, South Dakota, Tennessee, Texas, Washington, and Wyoming
- Employees who are set up in Pennsylvania and New Jersey
 - Pennsylvania and New Jersey have state taxes but different taxing rules
- Only VALID differences should be listed on the Federal to State Taxable Recon Tab
- List Pennsylvania as a positive number and all other states as a negative

FEDERAL TO STATE RECON TAB

- Only list Valid differences on the Federal to State Recon Tab
- Valid differences occur when an employee lives and works in a state that does not withhold state taxes. These states are Alaska, Florida, Nevada, New Hampshire, South Dakota, Tennessee, Texas, Washington, and Wyoming
- Pennsylvania and New Jersey have state withholding but different tax rules
- List Pennsylvania as a positive number and all other states as a negative
- For states with no SIT taxable, use QTD Federal Taxable wages on the V_PY_FIT_SIT_TAXABLE_VARIANCE query

FEDERAL & STATE TAXABLE DIFFERENCES

Invalid Differences

- Employees who have been set up incorrectly on Employee Tax Data screen
 - Employees who should have taxable gross and are set up as "no taxable gross, no tax taken" will cause differences. The system will not keep track of the taxable gross
 - The employee's Federal Tax Data should **NEVER** be set up as "no taxable gross, no tax taken"
 - Use "Maintain Taxable Gross" for employees who submit a tax form claiming exempt for taxes
- Balance Adjustments made in following quarter
 - If you had a difference in the previous quarter and the balance adjustment was keyed in the following quarter it will cause a difference
 - Cardinal looks at each quarter individually.
 - You will have a difference on the previous quarter because a correction was needed and you will have a difference for the same amount in the following quarter because the adjustment was made
 - Check the COVA Balance Adjustment Report
 - Navigator > Payroll for North America > Periodic Payroll Events USA > Balance Adjustments > COVA Balance Adjustment Report
 - Key the Explanation: "1st Otr adjustment keyed in 2nd Otr" on the Difference Explanation tab
 - No correction needed
- Balance Adjustment keyed incorrectly
- Run the V_PY_FIT_SIT_TAXABLE_VARIANCE query to find employees causing a difference
- All INVALID differences must be listed on the Differences Explanation Tab and corrected



- State column will be blank for states that do not have state taxes. When completing the Fed to State recon tab you will need to use the QTD Federal wages appearing on this guery
- Looks at the YTD for the most current tax record. If employee had multiple states set up throughout the year you will need check the YTD totals on the Balance Review/Taxes screen and add those states together
- For states that have different taxing rules (Pennsylvania, New Jersey) subtract QTD State Wages from QTD Federal Wages. Key this difference on the Fed to State Recon tab

OASDI/HI TAX DIFFERENCES

Valid Differences

- Imputed Life
 - Depending on the type of leave, the employee may continue to be covered by group life, in which case the imputed life should be calculated
 - Uncollected FICA is acceptable if it is caused by imputed income for group life
 - The system will self-adjust when the employee returns to a paid leave status. If the employee transfers to another agency the system will collect the uncollected FICA at the new agency
 - If the imputed life was deducted in error, you may reverse it thought payroll or submit a balance adjustment
 - Select Imputed Life from dropdown menu on the OASDI and HI tabs

Invalid Differences

- Pretax refund keyed incorrectly for a terminated employee
- Unadjudicated Flex for terminated employee processed incorrectly
- Balance adjustment incorrect
- Uncollected FICA at one agency collected at another
 - When an employee has uncollected FICA at one agency and transfers to/employed at another agency, the system automatically collects the uncollected FICA when the employee receives pay. Use the V_PY_FICA_TAX_VARIANCE query to find these employees
 - Agencies will need to submit a balance adjustment to correct the employee's record
- Invalid differences must be listed on the Differences Explanation tab and corrected



IF YOU HAVE INVALID UNCOLLECTED FICA

- You have to try to collect it from the employee
- Active
 - Collect it through payroll (System will automatically collect uncollected FICA from active employees)
- Terminated
 - Contact employee and try to get them to send in a payment
 - If you are successful and they send in the payment you will need to submit a Balance Adjustment to show it has been paid
 - Balance Adjustment to add amount to EE OASDI and EE FICA Med tax
 - If you cannot collect it from the employee you will need to Gross Up the amount using the FICA Gross Up Spreadsheet and key SPOT transaction for earnings code EPT, submit a Paysheet, and Balance Adjustment
 - Must be done prior to final payroll of the year
 - Check the V_PY_FICA_TAX_VARIANCE query prior to keying transactions to be sure the uncollected FICA was not collected at another agency

NEGATIVE BALANCES QUERY EXAMPLE

- In December healthcare in the amount of \$735.00 was deducted in error (Prior Year)
- When the refund was processed, the employee had \$245.00 in YTD for the current year
- Processing the refund in the current year caused a negative amount of -\$490.00 because the refund was more than the current YTD (\$245.00 \$735.00 = -\$490.00)
- To fix: Reverse the refund and pay as TXB

NEGATIVE BALANCES - REFUNDS

- Refunds for pre-tax deductions from a <u>previous</u> year should **NEVER** be processed in the current year. The only exception to this is a healthcare refund
- If a refund is due for healthcare from a previous year you may key it in the current year as TXB (taxable earnings) and not as a deduction refund
- To correct healthcare refunds that caused a negative balance, reverse the refund and key it as TXB. This must be done in the same payroll.
- If the healthcare refund is for the current year, process it through payroll as normal. The FICA taxes will automatically be deducted from the refund if the employee is terminated
- Retirement refunds should not be processed through payroll if it was withheld in a prior year. This results in non-compliance with IRS regulations related to retirement deductions. Process the refund outside of the payroll system and submit a W2C Request form
- For refunds keyed in error though payroll that caused a negative balance, the correction methods are on a case-by-case basis. You will need to submit a balance adjustment form or correct through payroll

CORRECTING DIFFERENCES

- Federal/State Invalid Differences
 - Submit a balance adjustment adding or reducing Federal or State Withholding (taxable gross) by the necessary amount
 - Update the Employee Tax Data screen to make sure it is now set up correctly

OASDI/HI Invalid Differences

- Correct through payroll if possible
- Contact the employee to try to get them to send in a payment if they are terminated
- If successful submit a balance adjustment increasing the Employee OASDI and HI tax
- If unsuccessful use the Gross Up spreadsheet to calculate the gross up amount and follow the instructions included on that spreadsheet
 - Must be done before last payroll of the year

Correct through payroll

Anything that can be corrected through payroll should be.



- 3. Year End Audit Data Report (last page only) (signed by Fiscal Officer)
- 4. COVA Error Listing Report (signed by Fiscal Officer)
 - Must mark up the report and provide an explanation for each employee listed <u>OR</u> complete the Cardinal Error Listing Report Calculation Spreadsheet. You must also include the date the error was corrected (if applicable).
 - The COVA Error Report to include should have been run after all of the balance adjustments have been made.
- 5. Upload the completed, signed packet to the Quarterly Reporting folder in SharePoint
- 6. You only need to submit the **pdf version** of the Year-End Certification packet

*******DO NOT** include balance adjustments with the <u>year end</u> certification. All balance adjustments must be submitted separately prior to submitting certification packet

********Updated Year End reports can be run the morning after the W2 data is refreshed. Quarterly reports can be run once the balance adjustment has been entered in HCM.



YEAR END

- DOA has a very limited amount of time to get the W-2's completed, taxes paid, and 941's filed
- Having a lot of year end adjustments drastically slows down the process
 - *******Adjustments should NOT be held until the end of the year
 - DOA cannot begin to create and print W2s or process 941s until all balance adjustments have been keyed for your agency
 - Per IRS rules, W2s must be given/mailed to employees by 1/31
 - Since DOA has to print, sort, count, and package the W2s for @ 107,000 of employees we
 need to have enough time prior to 1/31 to get that done and get them to the agencies in time
- Issues should be cleared up before year end
- Do not email DOA asking when W2s will be ready. We will contact you when they are ready
- Submit the W2 Distribution form by the required deadline (11/15)
- This is still a new system; reports and processes are evolving so year end procedures may change. Pay attention to all emails and Payroll Bulletins

ADHERING TO DEADLINES

- It is very important to submit your Quarterly Certifications on time
 - May be submitted before the due date
 - Late submissions will be reported in the Comptroller Quarterly Report
 - Auditors look closely at the Quarterly Certifications
- Do not wait until the last minute to start working on certifications
 - Reports are usually available the day after the payroll for the last check date in the month has been confirmed
- Incorrect and/or incomplete Quarterly Certifications will not be accepted
- When you are asked to make corrections and re-submit paperwork please do so as soon as possible
- If you have questions regarding the Quarterly Certification, attach an Excel copy of your certification to the email



ADDITIONAL REMINDERS

- State Tax records must be set up in the Company State Tax Table in HCM before the state can be added to the employee's Tax Data Record. Agencies must apply for withholding (where applicable) and UI (unemployment insurance) accounts for employee work states
 - For Unemployment Insurance, register as a Reimbursable Employer
 - To set up accounts in the tax table send an email to payroll@doa.virginia.gov. Include the following information:
 - Agency
 - State
 - State account number
 - UI account number
 - Filing frequency (annually, monthly, quarterly, weekly, semi-weekly, etc.)
 - Effective date
- If you are an agency that processes payroll for other agencies (i.e. Shared Services, DOC, PSB), you are responsible for sending 941 & W2C information to your agencies. This includes information regarding refunds and tax payments made by DOA
- When you receive letters from the IRS send a scanned copy of them to payroll@doa.virginia.gov
- If you receive a check from the IRS and you don't know what it is for, contact DOA **BEFORE** depositing the check
- If your agency closes, send an email to notify DOA and include the final check date wages were paid
- If you are looking for a form and you cannot find it on DOA's website (doa.virginia.gov) check Cardinal's website (cardinalproject.virginia.gov)

W2C REQUESTS

- When submitting W2C Requests you must <u>ALWAYS</u> submit a copy of the employee's W2 with the request
- Must include Social Security Number with the form. W2's no longer display SSN's on them
- Make sure you respond to the W2C emails in a timely manner
 - The system that creates the W2C will only keep it for a certain number of days and then deletes it. If it is deleted before it is submitted, the entire process from the beginning will have to be restarted
 - Make sure you are checking ALL of the information on the W2C Preview
 - Once the W2C is submitted to the Social Security Administration it cannot be reversed
- If the W2C results in a refund, you must check a box in the certification section on the W2C
 Request form
- There is a cheat sheet included on the W2C Request form that shows which categories should be adjusted
- If the W2C results in a balance due the IRS will sometimes charge interest which is the agency's responsibility (DOA will make the payment and charge the agency)
